## **STALLION BREEDING CONTRACT**

### **The Stallion Service Fee of \$1,750.00 is due and payable to Ell Dee Field**

A **non-refundable chute fee of \$600.00** is included in the stallion service fee. The chute fee must accompany this contract when it is completed and returned and is payable to Ell Dee Field.

**Shipped Semen:** First shipment of semen is included in Chute Fee. I agree to pay Equine Veterinary Services \$250.00 per each additional shipment of cooled semen via FedEx.

**I understand that all stallion service fees, collection fees and applicable shipping charges must be paid prior to any semen shipments.**

1. A copy of a Negative Coggins Test must be furnished upon the mare's arrival for on farm breeding. A copy of the mare's registration papers (both sides), and a copy of lease agreement (if applicable), must be furnished with the signing of this contract.
2. Mare owner warrants that the mare is in a healthy and sound breeding condition. For on farm breeding, it is agreed that Ell Dee Field shall check the above named mare for normal breeding conditions and perform such other veterinary services for the mare as is deemed necessary at the expense of the mare owner.
3. Neither Equine Veterinary Services, Dr. Kenton H. Arnold, employees or agents thereof, or Ell Dee Field shall be liable for the death, sickness and/or accident to the mare and/or foal. Ell Dee Field will exercise his best judgment in the care and supervision of your mare.
4. It is further agreed that should the above named stallion die or become unfit for service, or, if the mare dies or becomes unfit to breed, then this contract shall become null and void.
5. If the mare proves not to be in foal the year bred, then the stallion owner has the option to rebreed the same mare the following year, or request a substitute the following year, thereafter all fees will be forfeited if the mare is not pregnant. All veterinary fees, board fees and the collection fee will be charged as usual (same as above).
6. This contract contains a "**LIVE FOAL GUARANTEE**". A live foal is described as a new foal which stands and nurses without assistance. If the foal is born dead, return breeding privileges shall apply only if Ell Dee Field is notified within 48 hours thereof and receives a veterinarian's statement confirming death. Return breeding privileges apply only to the following breeding season. A substitute mare may be sent if the original mare is deceased or deemed unfit for breeding.
7. It is further agreed that the veterinary charges are due and payable upon receipt of a monthly statement. These charges are in addition to the stallion service fee. All fees, including the stud fee and expenses incurred shall be paid in full prior to the mare's departure from the facility.
8. The mare owner shall be responsible for reasonable attorney fees and court costs if necessary to collect fees due hereunder. It is expressly agreed that this contract is performed in Kaufman County, Texas and venue for any action hereunder shall be in Kaufman County, Texas.
9. This contract shall not be assigned or transferred by the mare owner without written consent of the stallion owner.
10. Any alterations of the contract without the initials of the stallion owner or agent, and breeding farm manager makes this contract null and void.
